EFFECTS OF ACUTE EXPOSURE

EYES: May cause eye irritation. Symptoms may include redness and pain.

SKIN: Non-irritating to the skin.

INHALATION: High concentrations of vapor or mist may cause nose, throat and respiratory tract irritation. Symptoms may include coughing.

INGESTION: May cause mouth, throat and stomach irritation. Symptoms may include nausea, vomiting and diarrhea. May also cause central nervous system effects including headache, dizziness and weakness.

EFFECTS OF CHRONIC EXPOSURE: Prolonged or repeated contact may cause skin irritation.

MEDICAL CONDITIONS AGGRAVATED: May aggravate pre-existing eye, skin and respiratory conditions.

4. FIRST AID MEASURES
